I - TRANSFER OR FINANCING OF SOCIAL RESIDENTIAL PROPERTY OR RIGHTS

BASE	DISCOUNT RATE FOR THE RELEVANT BRACKET
From 10.000.000 to 20.000.000€	20%
From 20.000.000 to 30.000.000€	30%
Above 30.000.000€	40% (maximum rate allowed)

II - FREE TRANSFER OF SHARES OR PROPERTY, EXEMPT FROM MUTATION DUTIES IN APPLICATION OF ARTICLES 787 B AND 787 C of the CGI

BASE	DISCOUNT RATE FOR THE RELEVANT BRACKET
Above 10.000.000€	40% (maximum rate allowed)

III - UNIVERSAL TRANSFER OF ASSETS OR CONTRIBUTION, TRIGGERING A TRANSFER OF PROPERTY

BASE	DISCOUNT RATE FOR THE RELEVANT BRACKET
Above 10.000.000€	40% (maximum rate allowed)
